..... **RULES** .....

1. The 20th annual Ocean House Marina Fluke Frenzy Tournament runs from June 21st through September 5th, 2009 (11 weeks). The tournament is open to all desiring to enter. The entry fee is \$25 per angler. This entry fee shall be non-transferable and non-refundable. It is preferred that all persons fishing on a given boat be registered in the tournament.
2. Eligible species shall be FLUKE (Summer Flounder). Minimum size shall be in accordance with 2009 DEM regulations.
3. Each participating angler may enter only one fish on each day of the tournament. All fish remain the property of the angler. Live bait, dead bait and artificial lures may be used. No entangling device or material may be used. Fish must be caught by hook in a conventional manner.
4. All fish entered in the tournament must be weighed on the Same Day they are caught, at Ocean House Marina "ONLY" during normal business hours (7:00am-5:00pm).
5. All decisions of the Tournament Committee shall be final. Violations of any tournament rules will not be tolerated. Any angler found to be in violation of any 20th Annual Ocean House Marina Fluke Frenzy rules will be disqualified.
6. All protests must be made in writing and filed with the Tournament Committee by the close of the weigh-in period on the day of the alleged infraction. No other protests will be considered.
7. The recipient of any award may be required to furnish his/her Social Security number and will be responsible for any taxes levied by any state or federal tax collecting agency. Prizes are accepted as awarded. The winner agrees that his/her name and photograph may be used for promotional purposes.
8. Participants in the 20th Annual Ocean House Marina Fluke Frenzy enter at their own risk. Officials, committee members, employees of Ocean House Marina and all other persons connected either directly or indirectly with the operation of the tournament shall be exempt from any liability for loss, damage, negligence, harm or injury suffered to any participant, entrant, boat captain, crew member, companion, vessel and equipment which may occur during the 20th Annual Ocean House Marina Fluke Frenzy.
